### Minutes of February 2016 EAA 402 Meeting

The meeting was called to order at 1900 by President Berne Volpe at the chapter clubhouse. The meeting was opened with the Pledge of Allegiance to the Flag. There were fourteen members and one guest present. Bernie welcomed all and thanked Rollie for clearing the snow allowing access to the clubhouse.

**Secretary's Report:** The secretary asked for approval of the January minutes as printed in the February newsletter. A motion to accept the minutes was made by Rollie Bailey, seconded by Barney Kemter. The motion carried. The secretary also reported on the flowers the chapter sent for Jack Maki's funeral; the donation to Newark Catholic Foundation in the name of George Fackler, Jr. and the donation made to Chapter 123 of the Order of the Eastern Star in memory of Pauline Ours. The secretary read a card from the Maki Family acknowledging the flowers. The secretary also mentioned that he contacted Fred Maki and offered to inform EAA so Jack will be listed in Sport Aviation in the Gone West column and Fred accepted the help. Rollie mentioned that the Fackler family was grateful for the donation to the Newark Catholic Foundation.

**Treasurer's Report:** Treasurer Ken Hughes gave the report. The ending balance as of February 16, 2016 was \$2,765.52. Contributions to the utility fund were \$133.00. Income from dues was \$306.00. Donations to the Jack Maki Memorial Fund was \$450.00.

Income from scrap metal and merchandise sales were \$0.00. Utilities paid: \$109.58. Other expenses: \$710.08. Included in the balance, were \$451.06 in the Utility Fund, \$308.88 in the Young Eagles Fund and \$450 in the Jack Maki Memorial Fund. A motion to accept was made by Bill Corban, seconded by Wendy Hollinger and approved by all members present.

**Fly Out Report:** Rollie reported on a "make up" flyout on Jan 30th to Richard Downing Airport (I40) at Coshocton, Ohio, . Four aircraft and 8

pilots/passengers made the trip. Details will be in the March newsletter. Flyouts for March 6th and March 20 are to be announced.

**Airport Board Report** by Bill Corban

- Bill reported that the changes in the lease arrangements for the clubhouse have not actually taken place as the change is still being discussed between the board and the airport operator.
- Bill reported that Herb Hall is in the process of replacing the external hangar lights with LED lights.
- Bill reported that there is continued discussion about repaving the rough apron area.
- Bill reported that the board is trying to move the construction of new T-hangars along by tagging along with county bond issues. He said the airport has 22 applications for T-hangars pending.
- In a non-board item, Bill explained about rearranging the pictures in the clubhouse in order to hang the Voyager poster, signed by Burt and Dick Rutan, that he promised at the last meeting. All agreed it was nicely done. Bill spoke about hearing Dick Rutan speak at Oshkosh about the Voyager flight.

**Newsletter Report** by Wendy Hollinger

Wendy had nothing to report and instead turned it over to Dale Ratcliff to present a plea for help on his project to build a mockup of 38 Charlie at the Works. Dale passed out lists of non-functioning instruments he needs for the panel and also asked for someone that might be able to paint the tail section of the plane. The plane will be on the second floor of the Works and the tail section will be on the outside wall.

**Old Business:**

The secretary brought up the Youth Protection program of the EAA and reported that the EAA has removed the requirement to provide social security numbers, instead making it voluntary. He also asked for all those who want to participate in Young Eagles events to go online and take course and sign up for the certification and to let him know when they have done so.

The secretary reported that he has contacted Steve Tufo to again cater the fly-in breakfast and asked if all agreed that would be acceptable. There was agreement among the members.

**New Business:**

Several of the members asked that we discuss what can be done to memorialize our recently deceased WWII pilot member Jack Maki. A number of possibilities were presented. Tom McFadden mentioned the memorial wall at Oshkosh (\$350min); Charlie Moore suggested a brick in the patio at Motts Military Museum in Groveport, Ohio (\$100); Ken Hughes suggested a plaque or picture in the FBO. There was considerable discussion about Charlie's suggestion of Motts with the result that a motion was made by Bill Corban and seconded by Charlie Moore and passed by the members to go with a brick at Motts Military Museum.

Ken Hughes said that he would like to see a memorial plaque with a graphic of the Grumman Hellcat on it. Ken is also going to put together a number of small models of the Hellcat and make them available to the members. Wendy and Dale volunteered to make the picture for the FBO.

A motion was made by Wendy Hollinger to allocate \$100 to Motts Military Museum for the brick and up to \$50 for a plaque or picture and hold the remainder of the memorial fund for future disposition. The motion was seconded by Barney Kemter. The secretary asked for clarification of the "memorial fund" and it was clarified by the treasurer that this is money that has been contributed to the chapter by members and non-members as a result of the notice in Jack's obituary that donations can be made to EAA Chapter 402 and this money was contributed for whatever purposes the chapter desires, not necessarily to create a memorial for Jack. A vote was then taken on the motion and it carried.

**Projects:**

Barney was going to report on his various projects but then said he just had too much to report!

**50/50 Drawing:** The drawing was won by Barney Kemter who donated his winnings to the utility fund.

Motion to adjourn was made by Bernie Volpe and seconded by Dick Perdue. The motion passed. The meeting was adjourned at 2010.
